This past year was a milestone for the Community Foundation for Cloud County. Your generosity, vision, and commitment powered another year of meaningful growth, and we couldn't be more grateful.

In Fiscal Year 2025, we welcomed 10 new funds, most made possible with the help of the Dane G. Hansen \$2,000 incentive. These funds are more than financial tools. They're seeds of long-term impact planted by people who care deeply about our county's future. With these additions, our total assets increased from \$13.4 million to \$15.1 million, a clear sign of momentum and trust.

Innovation also took center stage this year. Our new "We Love Cloud County" Surprise Grants brought a fresh burst of energy and joy to local initiatives. Designed to recognize and support creative, on-the-ground projects, these grants were met with enthusiasm and truly captured the generous, grassroots, and forward-thinking spirit of those who live in Cloud County.

We're also proud to share visible progress on two strategic doing initiatives. Several new murals now brighten our public spaces or are in the planning stages. These murals turn everyday walls into reflections of community pride and identity. After almost four years of planning, one of our most ambitious collaborative efforts, the Concordia Community Activity Center strategic doing project continues to move closer to reality with strong support from the Concordia City Commission.

Each of these achievements reflects what happens when our county invests in itself. We remain focused on building strong partnerships, amplifying local leadership, and supporting ideas that drive real change.

New Fund INCENTIVE

WHAT TO GIVE

There are many ways to give to the community foundation besides cash, including appreciated stocks and securities, retirement accounts, real estate, grain, and even cryptocurrency!

Depending on your financial situation, these could be a more tax-efficient way to give back to your community and should be discussed with your financial advisor.

Whatever you choose, we want to partner with you to help you make an impact today and transform tomorrow!

Appreciated Stocks & Securities



- Avoid long-term capital gains tax by donating appreciated stocks or securities that you have owned for over a year.
- Receive a charitable income tax deduction based on the full fair market value of the security.
- Examples include gifts of stock, bonds, and business interests.

Retirement Account



- Include the Foundation as a beneficiary of your retirement account. We receive the full amount and pay zero income tax, getting the entire benefit of your gift!
- If you are 70 1/2 or older you can contribute up to \$100,000 from your IRA directly to the Foundation (except for donor advised funds) and avoid paying income taxes on the distribution.

OTHER THAN CASH

Real Estate



- Avoid paying capital gains tax on sale of the real estate.
- Receive a charitable income tax deduction based on the full fair market value of the property.
- All gifts of real estate are liquidated with the proceeds of the sale going to the fund of your choice.

Grain



- Transfer and donate the grain to the community foundation's account at the grain elevator and the Foundation sells it with proceeds going into the fund of your choice.
- Avoid income tax on the donated grain.
- Deduct the production cost of the donated grain if applicable.

Cryptocurrency



- Donate your cryptocurrency using The Giving Block platform on our website.
- Avoid capital gains tax on appreciated cryptocurrency held for at least one year.
- Receive a charitable income deduction based on the full fair market value of the cryptocurrency.

HOW IT WORKS

Our mission is to build permanent resources that will be here forever to support your passions and make Cloud County a better place for future generations.

Here's How:

GIVE



You make a gift to an existing fund or establish your own charitable giving fund. Contribute cash, stock, grain or other complex assets, and receive an immediate tax deduction in the same calendar year.

GROW



We invest your funds for long-term growth, making sure that your donation and fund will be here forever to support your passions and Cloud County.

Our trailing 10-year annualized return is 7.80%.

GRANT



We distribute annual grants and scholarships from the funds based on criteria set by donors just like you to support local nonprofits and students.

Grants can be made in your name or anonymously.
